Text *A Walk Through Combinatorics* by Miklos Bona, with selections from other sources.

Course Objectives We will cover topics related to matchings, graph colorings, partial orders, block designs, combinatorial algorithms and special topics with time permitting.

Homework We will have nine homework assignments.

Quizzes We will have three quizzes. They will focus on the most recent material, but math courses are necessarily cumulative so later quizzes will use techniques developed earlier in the course. The quizzes will be on the following dates:

Quiz 1: February 16, Quiz 2: March 22, Quiz 3: April 19

Project There will be a project, including a 3–5 page writeup and an active component approximately equal to a homework assignment. Groups of up to three people are allowed. Depending on timing, there may be presentations.

Final Exam There will be a take home final exam during the final exam period.

Grading Grades will be assigned according to the following scheme:

The final grades will be curved, but will be no tougher than the 10-point scale: 90%-100% will be some form of A, 80-90% will be at least some form of B, etc. After each exam, you will receive a projected grade.
