This course is an introduction to formal mathematics. The emphasis in this course is not on learning facts, but rather on learning how to write clear and rigorous proofs. Some of the material covered in this course may be quite familiar to you. The goal is to understand and write about this material in a formal mathematical way. In addition to attending class, you are expected to carefully read the appropriate sections in the text, and spend time working problems. You are encouraged to get together with other students to discuss problems. Of course, for the problems which you turn in for a grade, you must write up your work individually, and you may not copy from another student.

Text: Daniel J. Velleman, How to prove it, a structured approach, second edition, Cambridge University Press, New York, NY 10013.

The assignments will be added here, as the course progresses. These assignments will not be turned in for a grade. Students are expected to do the assignments as part of the preparation for the exams.

Read the Introduction Pages 1 – 6, and Section 1.1, Pages 8 – 13. Work problems #1, 2, 3, 4, 7 (all parts of each).

Some homework assignments will be turned in for a grade. These will be added here.

Exam dates will be added here. Also, links to Sample Problems will be added here.

Grades will be based on three exams given in class during the semester, a cumulative final exam, and homework assignments. Each of the three exams during the semester will be worth 40 points. The final exam will be worth 50 points. Homework will be worth a total of 30 points. So there are 200 possible points. The final exam will be given during the regular final exam period for this section, which is Thursday, May 3, 7:30AM – 9:30AM. Grades will be assigned according to the following:
